RE: Application for Housing Preservation Grant, City of McCracken

Dear Ms. Trent:

I have received your request for comment by the Kansas Geological Survey on an application for a Housing Preservation Grant. The purpose of the grant is to make essential repairs to owner-occupied houses in the City of McCracken.

I reviewed the limited information you provided along with data from the McCracken 7½ minute topographic quadrangle, a geologic map and report on the geology of Rush County (Kansas Geological Survey Bulletin #207). The exact locations of the houses to be repaired were not provided. In the case of this project, the conditions are relatively similar throughout the City of McCracken. The city is located on a river terrace composed of alluvium and eolian (wind blown) sediments. These materials are permeable and drain well. Areas of alluvium are potential recharge areas for local aquifers. If hazardous liquids are used or encountered as part of the repairs, necessary precautions should be taken to prevent spills that might lead to aquifer contamination. As stated in your cover letter, it is important to follow requirements with regard to houses in the floodplain. Based on the above information, the Kansas Geological Survey has no knowledge of other geologic factors that would adversely affect this project.

This project will comply with appropriate state laws concerning the application.

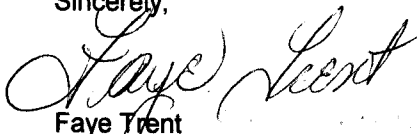
