Dear Ms. Galemore:

The Kansas Geological Survey (KGS) has received Southeast Kansas Regional Planning Commission's January 9, 2008, request for environmental comments. The City of Yates Center is submitting a Home Investment Partnerships Program grant application to the Kansas Housing Resources Corporation. The grant will fund the rehabilitation of approximately 16 residential structures within Yates Center, KS. After individual structures are identified, an individual environmental review will be completed on each structure by the applicant.

A review of regional geologic information along with a city map provided by you indicate that there are no unduly adverse geologic conditions that should affect this project. Environmental factors that could affect this project will likely be more site-specific (e.g., asbestos, lead paint, USTs, etc.) and will be evaluated after the structures are identified. For the purposes of the grant application, clearance of the project should proceed. A completed request for comments form is enclosed.

This letter is an assessment based on the regional geologic conditions available at the KGS at the time of writing and cannot be used in substitute of a detailed site characterization. Other geologic conditions, not discussed herein, or for which the KGS has no knowledge, may affect the viability or safe operation of this facility or property. It is the responsibility of the applicant to provide any necessary characterization, geotechnical or environmental testing, or design by a licensed professional geologist or engineer to complete the project.

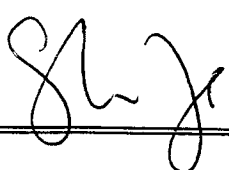
