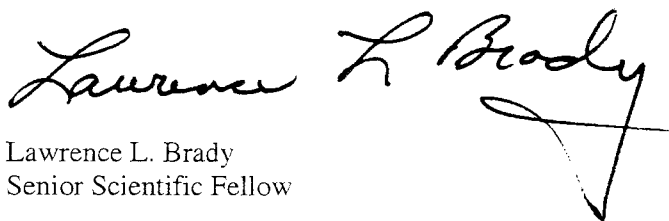
Dear Ms. Dienstbier:

I received your inquiry to the Kansas Geological Survey seeking input on the "Agency Review Transmittal Form" for the construction of a new Community Center for the town of Powhattan, Kansas. The project consists of the construction of a Community Center building on vacant lots in the central part of Powhattan. The proposed Community Center will contain a large community room, kitchen area, restrooms, and a small conference/archival library room with the building being fully handicap accessible.

It is my understanding that this review is necessary for the City of Corning to be considered for funding from the Kansas Department of Commerce CDBG Recovery Funds; determination must be made of any environmental effects that could occur due to the construction of this project. Based on the information provided to the Kansas Geological Survey, I do not anticipate environmental problems associated with the work on the new community center as long as the necessary OSHA requirements are met, and appropriate building codes are followed. Assuming these requirements and codes are followed, the Kansas Geological Survey provides the necessary clearance from our agency for your project.

The above discussion represents our best assessment based on the information that the Kansas Geological Survey has about this proposed project at the time of this writing. Other geologic conditions, not discussed herein, or for which the Kansas Geological Survey has no knowledge, might affect the safe construction of this project. The information provided in this letter is from regional or countywide studies and should not be used as a substitute for detailed site characterization by a licensed geologist or engineer. It is the responsibility of the applicant to provide any required site characterizations.

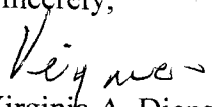
